Violation #55. Facilities installed, maintained, & clean

Observed missing ceiling tiles due roof leaks in cafeteria area. Repair roof leaks and provide ceiling tiles.

CODE REFERENCE: 64E-11.003(5). Floors, walls, and ceilings shall be smooth, durable, easily cleanable, and non-absorbent. Exterior areas shall be kept cleaned.
